Such records can include records of finding of delinquency or that a child was a member of a family with service needs (Conn. Gen. Stat. 46b-146), adjunction of youthful offender status (Conn. Gen. Stat. 54-142a). Further, any person whose criminal records have been erased is deemed under law never to have been arrested with respect to such erased proceedings and may swear so under oath.

A conviction record will not necessarily be a bar to employment, but factors such as recency, rehabilitation, and relatedness to fitness to perform the job in question will be considered. I also understand that as long as I remain an employee with Girl Scouts of Connecticut, the background search may be repeated at any time. In addition, I understand that a failed drug screen will be a bar to employment.

I understand that this employment application and any other Girl Scout documents are not contracts of employment, and that any individual who is hired may voluntarily leave employment upon proper notice and may be terminated by the council at any time. I also understand that I am submitting this application to become an employee of the Girl Scouts of Connecticut council and not GSUSA.
